Invitation for Bids for the Construction of Five Bed Hospital

1. The Government of Nepal, Ministry of Health and Population has allocated fund to Sunchhahari Rural Municipality for the **Construction of Five Bed Hospital at Pobang, Rolpa**. Bidding is open to all eligible as per Section V of bidding document.

2. **Sunchhahari Rural Municipality** invites electronic bids from eligible bidders for the construction of **Five Bed Hospital** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 38400000**
- Minimum Work experience of similar size and nature: at least **one project of NRs. 61300000**.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Bidder must have to submit their bid electronically and may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, must have to deposit the non-refundable fee of **NRs. 5000** on or before 12 hours on 17th Feb 2021 in the Project's Rajaswa(revenue) account as specified below. **Bank Name:- Nepal SBI Bank Ltd. 5. Pre-bid meeting shall be held at **Sunchhahari Rural Municipality, Pobang, Rolpa** on 9th Feb 2021 at 13 hours.

6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12 hours on 17th Feb 2021**. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend on **17th Feb 2021 at 14 hours** at the office of **Sunchhahari Rural Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 22000000**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in **Deposit Account No: 43525240600003**, at **Nepal SBI Bank Ltd, Sunchhahari, Rolpa**, or guarantee of any A Class Commercial Bank accredited by Nepal Rastra Bank.
